

## **IKP WG**

The IKP WG had two meetings this month and held discussions regarding the following key deliverables:

- **GDC Conference Recap:**

The WG presented on [wallet governance and the Accountable Wallet framework](#), emphasizing recovery, interoperability, and on-chain attestations. The group gained new collaborators, including Aira (under the [Linux Foundation](#)) and [Along ID](#), who expressed interest in aligning with the framework.



- **New Proposal on AI-Agent Standardization Frameworks:**

The WG introduced a **modular AI agent architecture**—Archive, Codex, and Discourse agents—to support automated governance, compliance, and memory retention. The system integrates Accountable Wallet principles and supports on-chain trust networks.

**Documents:** A [multi-part blog](#) and concept paper will be shared on [Discourse](#) and [GitHub](#).

**Webinar to be held:** A public webinar is planned for August 28 to present the framework and engage potential contributors ahead of Block #13.

**Agent GovHack:** [upcoming initiative](#) during Block #13 to prototype agent-based governance using AI. It aims to demonstrate how policy frameworks can be automated through a modular architecture agents.

It examines how events such as the Terra-Luna and FTX collapses shaped policy responses and highlights emerging challenges, emphasizing the need for global coordination to ensure stable and well-regulated digital assets.
